

Leaders Retreat Travel Voucher for Australia



The 2020 Leaders Retreat Travel Voucher Program ("Program") is open to Ambassadors residing in Australia and New Zealand who are of legal age by 1 August 2020. Employees of Plexus Australia PTY LTD (the "Company" or "Plexus") and its respective subsidiaries, affiliates, and agents, as well as the immediate family (spouse, parents, siblings and children) and household members of each such person are not eligible. The Program is subject to all applicable federal, state and local laws and regulations and is void where prohibited by law. Program participants are referred to as "you", "your" or "Participant".

Program period runs from 1 August 2020 at 12:00 a.m. USA ET through 31 October 2020 11:59 p.m. USA ET (the "Program Period").

This competition is a game of skill. Chance plays no part in determining the winners. All entries will be judged individually on their merits based on the quantity of credits the Participants obtain during the Program Period.

To be eligible to participate in this Program, you must be a "Qualified Ambassador" in "Good Standing" in accordance with Plexus' Ambassador Agreement and Policies and Procedures throughout the Program Period and until the prize is awarded. "Qualified Ambassador" is defined as:

- (i) Your Annual Web Hosting Fee (AWH) of 62.95 AUD must be paid and current.
- (ii) You have at least 100 in Personal Volume (PV) through the monthly cycle end date or you are a new Ambassador who purchased a Welcome Pack within the first 30 days of enrolment.
- (iii) You must be qualified to attend the Plexus 2021 Leaders Retreat to be held from 8 January 2021 through 10 January 2021 in Phoenix, Arizona.

"Good Standing" shall be defined to mean the following:

600 total PV – 250.00 USD Travel Voucher
1,200 total PV - 500.00 USD Travel Voucher
2,400 total PV – 750.00 USD Travel Voucher
3,600 total PV - 1,000.00 USD Travel Voucher

Note: Personal Volume (PV) is defined as the volume received from each commissionable product that you or your customers purchase.

Ambassadors will only earn the highest qualified level based on your PV. For example, if you achieved 3,600 total PV, you would earn the 1,000.00 USD travel voucher.

Winners must be eligible for and attend the 2021 Plexus Leaders Retreat in Phoenix, Arizona on 8 January 2021 through 10 January 2021

Winners (Qualified Ambassadors who achieve the above) will be notified via electronic mail no later than 27 November 2020. Ambassadors can only earn one voucher at the highest level achieved. Winners will receive their Travel Voucher in the form of a cash payment that will reflect in your Hyperwallet. In the event product returns and/or chargebacks after the winners are announced, the Company reserves the right to review and adjust the awarded Travel Voucher payment or deduct the amount of the Travel Voucher payment from your commission. In the event that you do not attend the 2021 Plexus Leaders Retreat from 8 January 2021 through 10 January in Phoenix, Arizona Plexus will deduct the amount of the Travel Voucher payment from your commission.
